Information we may collect from you

The legal basis for processing the following information is our legitimate interests, namely the proper administration of our website and business.

Method of collection

(a) Information that you provide by filling in forms on our website https://www.cleaningassurance.com/

This includes information provided at the time of registering to use our site, subscribing to our service, posting material or requesting further services. We may also ask you for information when you enter a competition or promotion sponsored by Cleaning Assurance Ltd and when you report a problem with our site.

- (b) If you contact us, we may keep a record of that correspondence.
- (c) We may also ask you to complete surveys that we use for research purposes, although you do not have to respond to them.
- (d) Details of your visits to our site including, but not limited to, traffic data, location data, weblogs and other communication data, whether this is required for our own billing purposes or otherwise and the resources that you access.

Our website and services are targeted at persons over the age of 18. If we have reason to believe that we hold personal data of a person under that age in our databases, we will delete that personal data.

Retaining and Deleting Data

All personal data will be retained for 12 months. At the end of this period it will be deleted from our systems if there has been no enquiry or contract placed with Cleaning Assurance Ltd within this 12 month period. However, this will also depend on any pending guarantee period, legal or insurance issue.

Updating your Information

IP addresses and cookies

We use session cookies which collect information for statistical data about our users' browsing actions and patterns, and does not identify any individual. The legal basis for processing the following information is our legitimate interests, namely the proper administration of our website and business.

Where we store your personal data

Cleaning Assurance does not transfer any personal data to counties outside of the European Economic Area (EEA).

All necessary steps will be taken to ensure that your data is treated securely and in accordance with this privacy policy. Therefore, once we have received your information, we will use strict procedures and security features to prevent unauthorised access.

Uses made of the information

We use information held about you in the following ways:

Your rights

Access to information
